2014 PARTICIPANTS LIABILITY RELEASE & HOLD HARMLESS AGREEMENT

By my signature and acceptance below, I hereby enter into this binding Liability Release & Hold Harmless Agreement (hereafter referred to as the "Agreement"). I understand and acknowledge: (a) that the Mud-n-Stuff Run (hereafter referred to as the "Run") could be potentially hazardous; ( b) that the Run involves some strenuous physical activity that may present a significant challenge and risk of injury to myself and/or others; (c) that I am familiar with the risks involved; and (d) that I should not enter and participate unless I am medically able and properly prepared.

I understand participation in the Run is allowed in consideration of payment of the entry fee and my entering into this Agreement, and I acknowledge that such participation is adequate consideration for the rights herein released and obligations undertaken.

Therefore, for myself and my heirs and executors, I hereby: (a) assume all risks (known and unknown) associated with or arising out of my participation in this Run, including but not limited to, falls, drowning, contact with objects, spectators, and other participants, occurrences associated with weather, conditions of water and the terrain, and conditions of traffic, roads and trails; (b) waive any and all specific notice of the existence of these and any other such hazards or conditions; (c) assume full and complete responsibility for any injury or accident arising out of or associated with my participation in this Run; and (d) **RELEASE** MUD-n-STUFF, Cascade Days Association, and Town of Concrete, directors, officers, employees, volunteers, or any agent or representative of them (collectively referred to as the "Sponsoring Organization") and **INDEMNIFY** and **HOLD HARMLESS** the Sponsoring Organization from any and all liability, cause of action, claims, demands, cost or debts of any kind or nature, associated with or arising from or out of my participation in this Run, whether such claims are based on negligence or otherwise and whether brought by myself or by any third persons (collectively referred to as "Claims")

If Runner is under 18 years of age, the parent/guardian’s signature on this Agreement constitutes parent/guardian’s **RELEASE** and promise to **INDEMNIFY** and **HOLD HARMLESS** the Sponsoring Organization for parent/guardian’s Claims, Additionally, parent/guardian agrees to **INDEMNIFY**, **DEFEND**, and **HOLD HARMLESS** Sponsoring Organization for Claims by Runner against Sponsoring Organization.

I grant to all of the foregoing to use any photographs, motion pictures, records, or any other record of this event for any legitimate purpose and I understand that my name will be listed in the results posted in media publications including but not limited online and newspapers. \_\_\_\_\_ (initial)
