- Parade Route:** Begins at the Concrete Post Office, ends with a party in Town Center. Go all the way to the end of Main Street, turn left and circle back to Baker Street.
Don't go too fast. Take your time, enjoy the journey.
- Judging:** Mardi Gras Royalty judges from in front of the Concrete Theatre. Winners will be announced within an hour afterward.
- 4 Categories:** Best Krewe (group, organization or business)
Best Dressed Adult
Best Dressed Youth (under 13)
